 wife removing substantial monies from the husband's bank account, and attorney's fees.
 - I was involved in a very disturbing child abuse case in dependency court. The father
 was sexually abusing the minor child for some time. The father's parental rights were
 ultimately terminated.
 - 3. I represented a father in a relocation case where the mother wanted to move out of the State of Florida with the children. At that time, the mother had sole custody of the children and the father had limited access to them. We were successful in preventing the mother from taking the children and the father ultimately got custody of the children.
